ARTICLES OF ORGANIZATION of WJD REAL ESTATE HOLDINGS, LLC a Florida Limited Liability Company These Articles of Organization are adopted for the purpose of forming a limited liability company under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

The name of the Company is WJD Real Estate Holdings, LLC.

ARTICLE TWO: PRINCIPAL OFFICE AND MAILING ADDRESS

Additional Members shall be admitted to the Company only in accordance with the Operating Agreement. No Membership Interest may be transferred and no additional Members shall be admitted to the Company except as specifically set forth in the Operating Agreement and in strict compliance therewith.
