ARTICLES OF ORGANIZATION OF CESSB, LLC,

a Florida Limited Liability Company

The undersigned, being the duly authorized representative of the initial members of a junited liability company to be organized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I NAME
