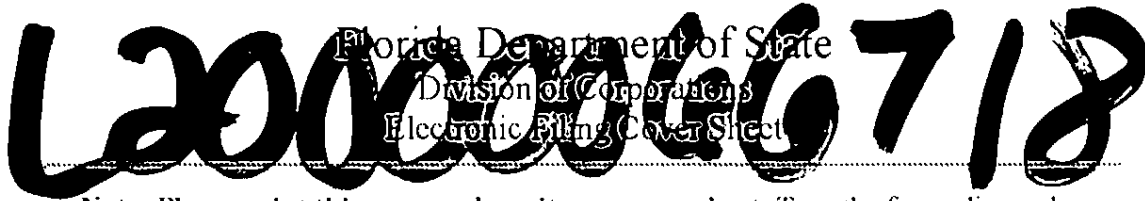


**ARTICLES OF DISSOLUTION FOR




1. The name of the limited liability company is Roof Repair Squad, LLC.
