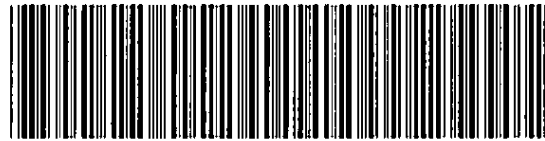

Informal Action of Members

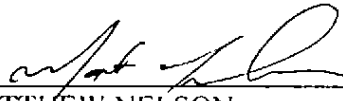

An interest of a Member of this Company may be transferred or assigned only to such extent and in the manner provided in the Operating Agreement.

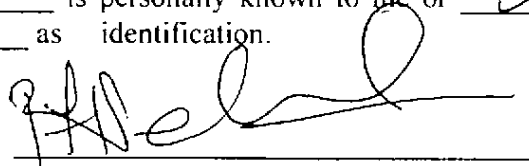
