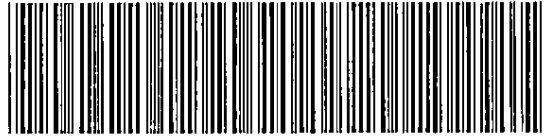

REGISTERED AGENT AND REGISTERED OFFICE**


The name of the Registered Agent is LINDA BAMMANN. The Registered Office is located at 9295 NW Highway 225A, Ocala, Florida 34482.


