

§ 1001.1 Definitions.

As used in this chapter:

- (a) The terms defined in section 101 of the <u>Immigration and Nationality Act</u> (66 Stat. 163) shall have the meanings ascribed to them in that section and as supplemented, explained, and further defined in this chapter.
- **(b)** The term *Act* means the <u>Immigration and Nationality Act</u>, as amended.
- (c) The term **Service** means the Immigration and Naturalization Service, as it existed prior to March 1, 2003. Unless otherwise specified, references to the Service on or after that date mean the offices of the Department of Homeland Security to which the functions of the former Service were transferred pursuant to the Homeland Security Act, Public Law 107-296 (Nov. 25, 2002), as provided in 8 CFR chapter I.
- (d) The term *Commissioner* means the <u>Commissioner</u> of the Immigration and Naturalization <u>Service</u> prior to March 1, 2003. Unless otherwise specified, references to the <u>Commissioner</u> on or after that date mean those officials of the Department of Homeland Security who have succeeded to the functions of the <u>Commissioner</u> of the former Service, as provided in 8 CFR chapter I.
- (e) The term Board means the Board of Immigration Appeals.

- law in and is a member in good standing of the bar of the highest court of any State, possession, territory, or Commonwealth of the United States, or of the District of Columbia, and is not under any order suspending, enjoining, restraining, disbarring, or otherwise restricting him in the practice of law.
- (g) Unless the context otherwise requires, the term *case* means any proceeding arising under any immigration or naturalization law, Executive order, or Presidential proclamation, or <u>preparation</u> for or incident to such proceeding, including preliminary steps by any private person or corporation preliminary to the filing of the application or petition by which any proceeding under the jurisdiction of the Service or the Board is initiated.
- (h) The term *day* when computing the period of time for taking any action provided in this chapter including the taking of an appeal, shall include Saturdays, Sun <u>days</u>, and legal holi <u>days</u>, except that when the last <u>day</u> of the period so computed falls on a Saturday, Sunday or a legal holiday, the period shall run until the end of the next <u>day</u> which is not a Saturday, Sunday, nor a legal holiday.
- (i) The term *practice* means the <u>act</u> or <u>acts</u> of any person appearing in any case, either in person or through the <u>preparation</u> or filing of any brief or other document, paper, application, or petition on behalf of another person or client before or with <u>DHS</u>, or any <u>immigration judge</u>, or the <u>Board</u>.
- (j) The term **representative** refers to a person who is entitled to represent others as provided in §§ 1292.1(a) (2), (3), (4), (5), (6), and 1292.1(b) of this chapter.
- (k) The term *preparation*, constituting <u>practice</u>, means the study of the facts of a case and the applicable laws, coupled with the giving of advice and auxiliary activities, including the incidental <u>preparation</u> of papers, but does not include the lawful functions of a notary public or <u>service</u> consisting solely of assistance in the completion of blank spaces on printed Service forms by one whose
