ARTICLES OF ORGANIZATION
of
COASTAL VALLEY WEALTH MANAGEMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Coastal Valley Wealth Management, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 183 Landrum Lane, Suite 103, Ponte Vedra Beach, Florida 32082.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VII


DURATION AND COMMENCEMENT

CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE


