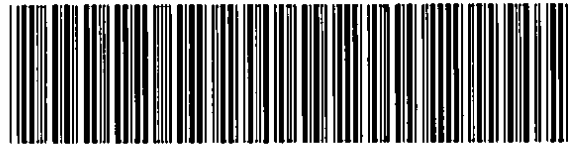


ARTICLE IV: MANAGEMENT
