1. Name. The name of the Limited Liability Company shall be MRK BUTLER, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 8160 Sabal Oak Lane, Jacksonville, Florida 32256.


9. The date of the existence of the limited liability shall be the date of the filing of the Articles of Organization by the Department of State of the State of Florida.
