**ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION  
OF  
FAMAGO INVESTMENTS LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **FAMAGO INVESTMENTS LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

**FIRST:** The Articles of Organization of FAMAGO INVESTMENTS LLC were filed with the Florida Department of State on March 12, 2020 and assigned document number L20000075723.

**SECOND:** The Company's Articles of Organization are hereby amended by deleting Article II of the Articles of Organization and replacing it with the following new Article II:

**"ARTICLE II. ADDRESS"**

The principal and mailing address office of the Company is 255 Alhambra Circle, Suite 560 Coral Gables, FL 33134."

**THIRD:** The Company's Articles of Organization are hereby amended by deleting Article III of the Articles of Organization and replacing it with the following new Article III:

**"ARTICLE III. REGISTERED AGENT AND OFFICE"**

The Company designates 255 Alhambra Circle, Suite 560 Coral Gables, FL 33134 as the street address of the Company's registered agent and names Octavio A. Verdeja as the Company's registered agent at that address to accept service of process within this state."

**FOURTH:** The Company's Articles of Organization are hereby amended by deleting Article V of the Articles of Organization and replacing it with the following new Article V:

**"ARTICLE V. MANAGEMENT"**


