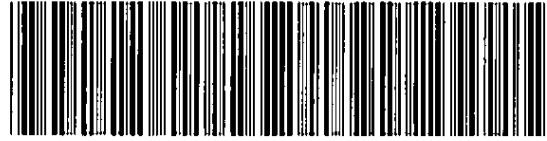

OF

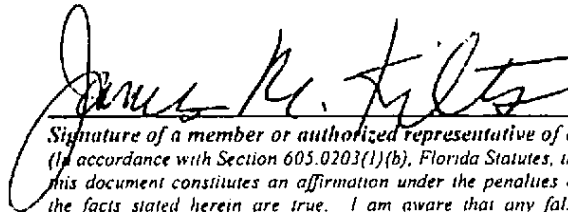
ARTICLE 3
