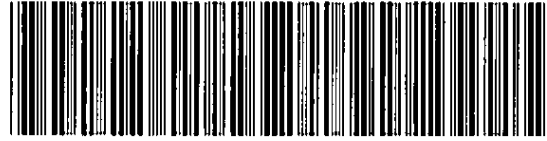

ARTICLES OF ORGANIZATION
OF


ARTICLE 3
