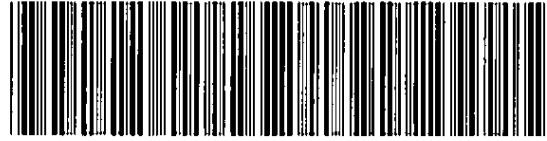

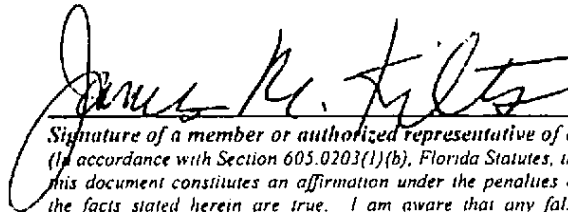
ARTICLE 3
