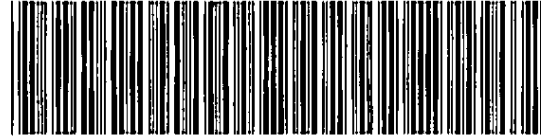

forward with our business plans.


