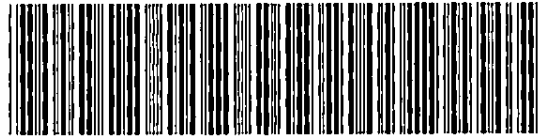

Pursuant to the Provisions of the Florida Statutes, the undersigned organizer hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I  
NAME**

The name of the limited liability company is PC TRUCKS, LLC (the "Company").

**ARTICLE II  
DURATION**

The Company shall have a duration from the date of organization until December 31, 2099, unless it is dissolved and its affairs wound up prior to that date in accordance with the Florida Limited Liability Company Act (the "Act").


**ARTICLE III  
PURPOSES**

The purpose for which the Company is formed to own and operate an auto dealership, and do all activities associated therewith, and to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. The Company is not to engage in any act or activity requiring any consents or approvals by law without such consent or approval being first obtained.

**ARTICLE IV  
REGISTERED OFFICE; REGISTERED AGENT**

The location and street and mailing address of the initial registered office of the Company shall be 2815 15<sup>th</sup> Street, Panama City, Florida 32405. The registered agent at such address shall be LLOYD KEEL.
