## ARTICLES OF ORGANIZATION OF COMPREHENSIVE BIOLOGICS, LLC

The undersigned, John Fisher, a natural person competent to contract and an authorized representative of Comprehensive Biologics, LLC, hereby presents these Articles of Organization as the Articles of Organization of Comprehensive Biologics, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

### ARTICLE I - NAME

The name of the limited liability company is Comprehensive Biologics, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
