FINAL JUDGMENT OF SIMPLIFIED DISSOLUTION OF MARRIAGE

THIS CAUSE came before the Court for a videoconference hearing on January 27, 2022, on the Petition for Simplified Dissolution of Marriage. The wife appeared *Pro Se*. The Husband failed to appear after being properly noticed. The Court, having reviewed the file and heard the testimony, makes these findings of fact and reaches these conclusions of law:

- 1. The Court has jurisdiction over the subject matter and the parties.
- 2. At least one party has been a resident of the State of Florida for more than 6 months immediately before filing the Petition for Simplified Dissolution of Marriage.
- 3. The parties have no minor or dependent children in common, and neither party is pregnant.
- 4. The marriage between the parties is irretrievably broken.
- 5. The Wife wishes for her former name to be restored to **Heidi Jo Cook**.
- 6. The parties have voluntarily entered into a Marital Settlement Agreement which was filed in the court file on October 5, 2021.

Therefore, it is **ORDERED AND ADJUDGED**:

A. The marriage between the parties is dissolved and the parties are restored to the status of being single.
