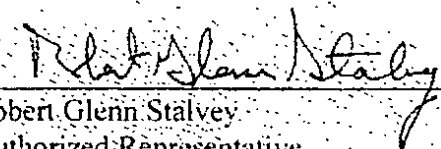
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

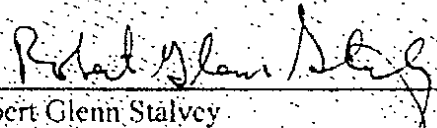
