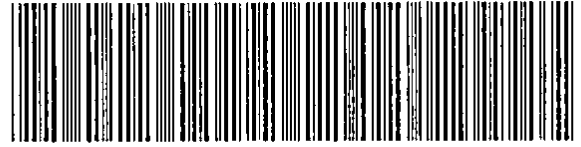

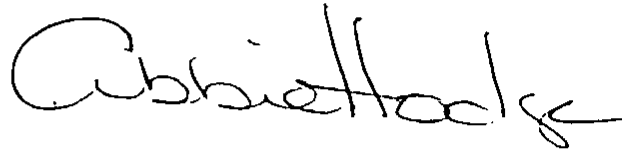

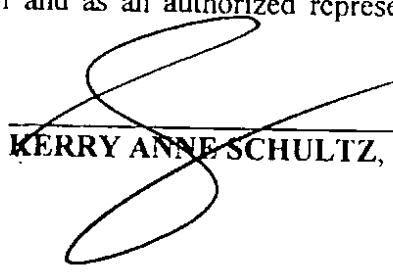
ARTICLE IX - MANAGEMENT

ARTICLE X - AMENDMENT

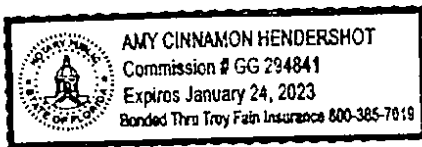
