## ARTICLES OF ORGANIZATION SUNCOAST URBAN DEVELOPMENT, LLC A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida limited liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I. NAME

The name of the limited liability company is SUNCOAST URBAN DEVELOPMENT, LLC (the "Company").

### ARTICLE II. ADDRESS

The Company is a member-managed Company.

#### ARTICLE VI. REGISTERED AGENT AND OFFICE
