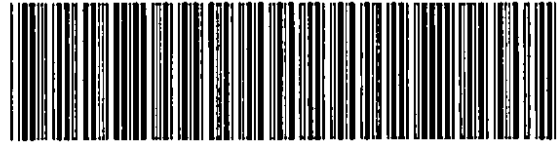

1. Pursuant to F.S. §605.0202, the Articles of Organization of the above referenced Limited Liability Company are amended in accordance with the following:

FIRST: The date of filing of the Articles of Organization was March 31, 2020 under document number L20000093742.

SECOND: The following amendments to the Articles of Organization have been adopted by the limited liability company:

ARTICLE IV - MANAGEMENT

The limited liability company is managed by one manager or more managers and is therefore, a manager-managed company. The names and addresses of the managers are: Darcelle L. Jacob, 7071 Wild Horse Circle, Sarasota, Florida 34241.

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

No additional members shall be admitted to the company except upon the written consent of a three-quarters (3/4) majority of the voting-members of the company. A member may transfer his/her/its interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company, or to become a member unless the managers and a three-quarters (3/4) majority interest of the voting-members of the company (exclusive of the member proposing to dispose of his/her/its interest) approve of the proposed transfer in writing.

ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS


The remaining members of the limited liability company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of

any other event which terminates the continued membership of a member in the limited liability company.

E. Pursuant to the provisions of Chapter 605 of the Florida Statutes, these Articles of Amendment shall be effective upon the date of filing.
