# ARTICLES OF AMENDMENT 1022 APR -5 AM 7: 50 TO ARTICLES OF ORGANIZATION TALLAHASSEE, FL OF DARCI, LLC

Pursuant to F.S. §605.0202, the Articles of Organization of the above referenced Limited Liability Company are amended in accordance with the following:

FIRST: The date of filing of the Articles of Organization was March 31, 2020 under document number L20000093742.

### **ARTICLE IV - MANAGEMENT**
