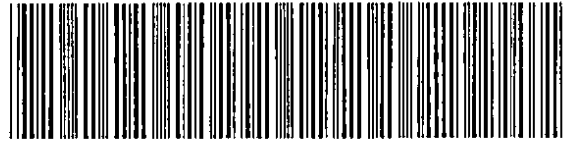

ARTICLE I

(Name and Principal Place of Business; E-mail address)

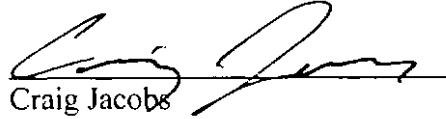
