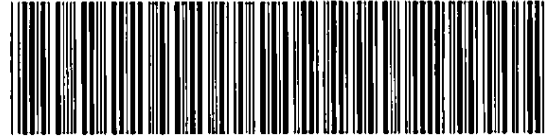

**SECOND AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF
CLIPS 52 LLC**
(a Florida limited liability company)

CLIPS 52 LLC, a Florida limited liability company (the "LLC") filed Articles of Organization on January 27, 2020 and amended the same on July 6, 2020. The LLC was assigned a Florida document number L20000094628. Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby adopts the following Amendment to the Articles of Organization:

1. The LLC's Articles of Organization are hereby amended by deleting Article IV thereof in its entirety and substituting in lieu thereof a new Article IV to read as follows:

"Article IV

The name and Florida address of the registered agent is **BELLER SMITH, P.L.**, 2101 NW Corporate Blvd., Suite 316, Boca Raton, Florida 33431."

2. The LLC's Articles of Organization are hereby amended by deleting Article V thereof in its entirety and substituting in lieu thereof a new Article V to read as follows:

"Article V

The name and address of the persons authorized to manage the LLC are **CRISSELLE SANTANA, WALTER C. WRAY, III and YOENIS CESPEDES.**"

3. The LLC's Articles of Organization are hereby amended by adding and inserting a new Article VII to immediately follow Article VI to read as follows:

"Article VII

Pursuant to Section 605.0407, Florida Statutes, the Company is a manager-managed company."

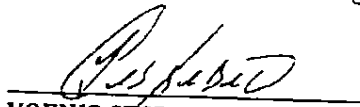
