**ARTICLES OF ORGANIZATION

James IV, a natural person competent to contract and an authorized representative of PPP Loans Agent, LLC, hereby presents these Articles of Organization as the Articles of Organization of PPP Loans Agent, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is PPP Loans Agent, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


