ARTICLES OF ORGANIZATION

OF

ARTICLE I NAME; APPLICABLE LAW

The name of the fimited liability company formed pursuant to the filing of these Articles of Organization (the "Articles") is "PROGRESSIVE HOSPITALITY GROUP LLC" (the "Company"). The Company is created pursuant to and in accordance with the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (as amended from time to time, the "LLC Act"). The number of managers ("Managers") shall be determined as provided in the Operating Agreement and the Managers shall have the powers, duties and authority set forth in the LLC Act, subject to any express limitations contained in the Operating Agreement. ARTICLE VI RESTRICTIONS ON TRANSFER; ADMISSION OF ADDITIONAL OR SUBSTITUTE MEMBERS

Among other things, the Operating Agreement restricts the sale, transfer, pledge, hypothecation, exchange, assignment or other disposition by any means, including but not limited to those which are voluntary, involuntary, by operation of law, by the laws of descent and distribution, or otherwise (each, a "Transfer"), of the membership interests in the Company. Any such Transfer shall be void ab initio unless made in strict compliance with the terms and conditions of the Operating Agreement. In addition, no person or entity shall be admitted as a member of the Company, be issued a membership interest in the Company, or have the right to become a member of the Company, whether in substitution for another member or as an additional member, except in accordance with the Operating Agreement.

ARTICLE VII AMENDMENTS

These Articles may not be amended except as provided in the Operating Agreement.
