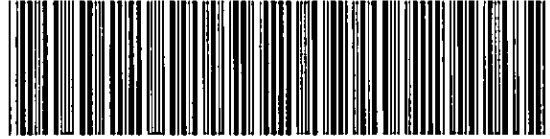

**Operating Agreement**




