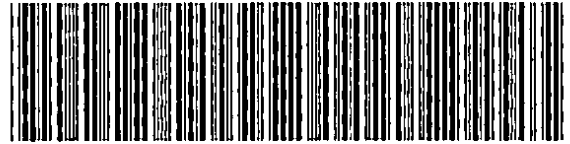


**ARTICLE VIII**


