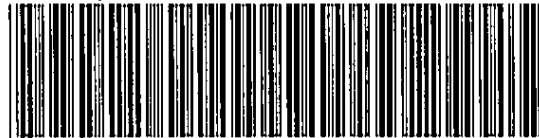



- d. Agrees to furnish a copy of the agreement of merger on request and without cost to any member of the surviving company or merging company.


