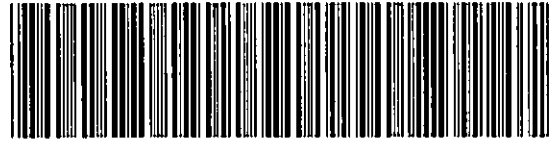

The Articles of Organization for the Limited Liability Company were filed on April 14, 2020, and assigned Florida Document Number L20000103066.

This amendment is submitted to amend the following:

A. The name of the limited liability company is changed to **5222 MEDINA A, B, C and D, LLC**.

B. Management of this limited liability company is reserved to its members (who may be referred to herein or in the Regulations or other documents regarding this limited liability company as "manager" or "managers") whose names and addresses are as follows:

Each member shall be entitled to the distributive share of the profits specified as follows:


John E. Williams	50%
