**ARTICLES OF ORGANIZATION
OF
SEVEN SISTERS AND A BROTHER LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Seven Sisters and a Brother LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is c/o Marilyn Holifield, 701 Brickell Avenue, Suite 3300, Miami, FL 33131.

ARTICLE III. REGISTERED AGENT AND OFFICE

The Company designates 801 US Highway 1, North Palm Beach, FL 33408 as the street address of the Company's initial registered agent and names Corporate Creations Network as the Company's initial registered agent at that address to accept service of process within this state.
