**ARTICLES OF ORGANIZATION
OF
C&J RE HOLDINGS LLC**

The undersigned, JEFFREY W. HOYE, a natural person competent to contract and an authorized representative of C&J RE HOLDINGS LLC, hereby presents these Articles of Organization as the Articles of Organization of C&J RE HOLDINGS LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is C&J RE HOLDINGS LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and initial principal address of the Company is 55 Seastone Court, Inlet Beach, FL 32461-9504. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS
