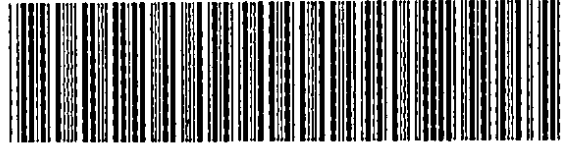

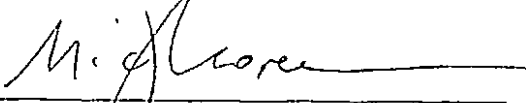
1. The name of the Florida corporation immediately prior to the filing of the Articles of Conversion is JCCR General, Inc. - P97000034589
