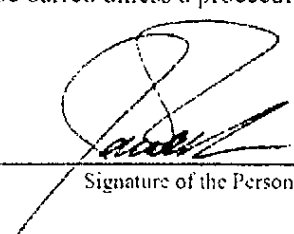

Pursuant to Section 605.0707 of the Florida Revised Limited Liability Company Act (the "Act"), Cardea Services, LLC does hereby submit the following Articles of Dissolution:

ARTICLE I – NAME

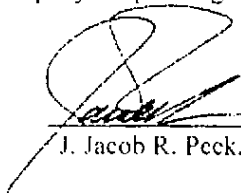
