**ARTICLES OF ORGANIZATION**  
*of*

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be JMH SH, LLC (the "Company"). The mailing address of the principal office of the company shall be P.O. Box 3317, Ponte Vedra Beach, Florida 32004 and the street address of the principal office of the Company in Florida shall be 47 Ponte Vedra Boulevard, Ponte Vedra Beach, Florida 32082.

**ARTICLE II**

**PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. **ARTICLE VII**


**DURATION AND COMMENCEMENT**

**CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE**


