

## ARTICLES OF ORGANIZATION OF 660 NE OCEAN BLVD MANAGEMENT LLC

The undersigned, for the purpose of forming a Limited Liability Company under the "Florida Revised Limited Liability Company Act," F.S. Chapter 605 (the "Act"), does hereby adopt the following Articles of Organization:
