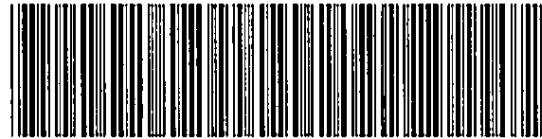

**ARTICLES OF ORGANIZATION OF
Sustainable Scrubber LLC**

These original Articles of Organization (hereinafter "the Articles") of Sustainable Scrubber LLC (hereinafter the "Company") are deemed effective in accordance with Fla. Stat. § 605.0207 as of the earlier date of either the date upon which the Florida Division of Corporations received these Articles for filing or the date that is five business days before the date of filing these Articles with the Florida Division of Corporations; whichever date is earlier. These Articles have been duly executed and are being filed in accordance with Florida Statute § 605.0201 and have been signed by a member of the Company.

I. ARTICLE I: Name

The name of the Limited Liability Company is Sustainable Scrubber LLC.

II. ARTICLE II: Duration

Unless earlier terminated under by Statute or by the Operating Agreement, the period of duration of the Company shall be perpetual.

III. ARTICLE III: Purpose

The purpose of the Company shall be to develop, design, manufacture and produce sustainable products and engage in any lawful business related thereto that may be engaged in by a limited liability company organized under the Act, as such business activities may be determined by the Members from time to time. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

IV. ARTICLE IV: Address Of Place Of Business

The principal place of business and mailing address for the Company is 5645 Coral Ridge, Suite 437, Coral Springs, FL, 33076. These addresses may be changed from time to time as provided for in the Operating Agreement, or by amendment to these Articles, provided that all members of the Company have consented to such amendment.

V. ARTICLE V: Registered Agent

The registered agent in Florida for the Company is Florida Entrepreneur Law, P.A. whose address is 101 NE 3rd Ave., Suite 1500, Fort Lauderdale, FL 33301. I, Michelle Suarez, Esq., on behalf of Florida Entrepreneur Law, P.A., accept the appointment of Registered Agent of the Company, and have read and am familiar with the requirements and obligations required of Registered Agents as set forth in Fla. Stat. § 605.0113.

VI. ARTICLE VI: Capital Contributions

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

VII. ARTICLE VII: Members

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement. At the time of the filing of these Amended Articles of Organization, the Company has two Members: Timothy T. Haak and Steven M. Vosberg.

VIII. ARTICLE VIII: Continuity of Business

The Company's duration shall be perpetual unless judicially dissolved under the Revised Florida Limited Liability Company Act, or unless another event stated in the terms of the Operating Agreement which would cause dissolution occurs.

IX. ARTICLE IX: Management

This Company will be Member Managed in accordance with the terms of the Operating Agreement.

ARTICLE X: Indemnification

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
