**ARTICLES OF ORGANIZATION
OF
MIGUEL A. GUTIERREZ-DIAZ, D.O., PLLC**

The undersigned, Miguel A. Gutierrez-Diaz, D.O., a natural person competent to contract and member of MIGUEL A. GUTIERREZ-DIAZ, D.O., PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the professional limited liability company is MIGUEL A. GUTIERREZ-DIAZ, D.O., PLLC. This professional limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and street address of the principal office of the Company is 4700 Bayou Blvd., Suite 2C, Pensacola, Florida 32503. The Company's mailing address and principal office may hereafter be at such other place or places as its member or members from time to time may determine.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for the purpose of providing professional medical services and for any other legal and lawful purpose for which a professional limited liability company may be organized and shall have all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act and the Revised Limited Liability Company Act as such Acts presently exist or as they may hereafter be amended.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be effective on May 5, 2020, and the Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI – MANAGEMENT

The Company shall be a manager-managed professional limited liability company and will be managed in accordance with the terms of the Operating Agreement of the Company. ARTICLE VII – AMENDMENT
