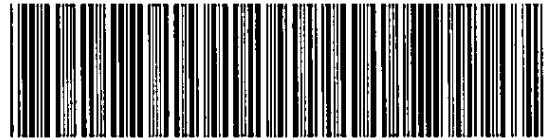

**AMENDMENT**

Upon filing of this document, the Limited Liability Company is member-managed and is no longer manager-managed.

**RESTATEMENT**
