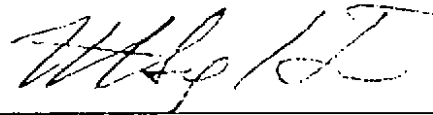

Management of Business

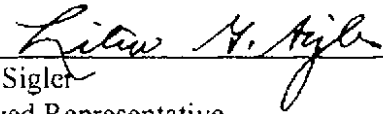
