ARTICLES OF ORGANIZATION OF BEACHFRONT TRAIL 204, LLC

The undersigned, Craig Magleby, a natural person competent to contract and an authorized representative of Beachfront Trail 204, LLC, hereby presents these Articles of Organization as the Articles of Organization of Beachfront Trail 204, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Beachfront Trail 204, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE VI – MANAGEMENT




