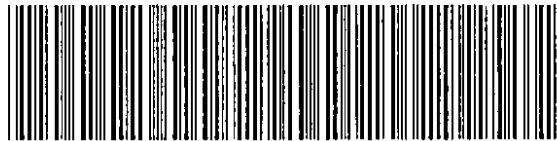

ARTICLES OF ORGANIZATION



ARTICLE VI - MANAGEMENT



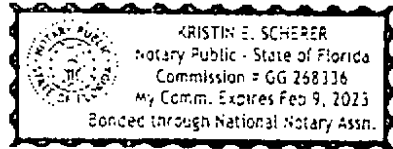


