ARTICLES OF ORGANIZATION OF XUDE EAGLES, LLC

- 1. <u>Name</u>. The name of this limited liability company is XUDE EAGLES, LLC (the "<u>Company</u>"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
