The name of the limited liability company is OHM Style, LLC.

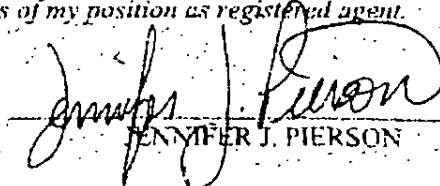
ARTICLE II. ADDRESS

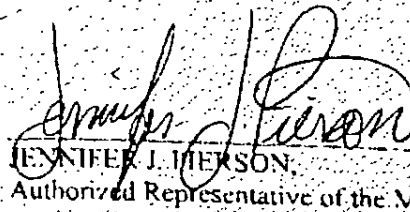
