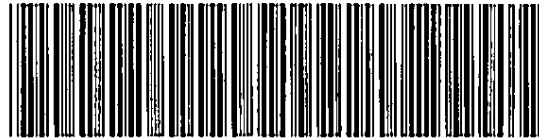

**ARTICLES OF ORGANIZATION**  
**OF**  
**ITD SAFETY, LLC**  
**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned does hereby execute these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I—NAME

The name of the limited liability company is ITD SAFETY, LLC ("Company").

ARTICLE II—PERIOD OF DURATION

The period of duration of the Company shall be perpetual.

ARTICLE III—PURPOSES

The Company may engage in the transaction of any or all lawful business for which limited liability companies may be formed under the laws of the State of Florida.

ARTICLE IV—ADDRESS AND PLACE OF BUSINESS

The mailing address of the Company is 2475 Palm Bay Rd., Suite 110, Palm Bay, FL 32905, and the street address of the principal office in Florida is 2475 Palm Bay Rd., Suite 110, Palm Bay, FL 32905.

ARTICLE V—REGISTERED AGENT/OFFICE

The Company may change its registered office or its registered agent, or both, by filing a statement with the Florida Department of State in accordance with Section 605 of the Florida Statutes.

ARTICLE VI—MANAGEMENT

All powers of the Company shall be managed by or under the authority of, and the business and affairs of the Company shall be managed by or under the direction of the Board of Managers of the Company. The Board of Managers shall consist of the number of persons elected in the manner prescribed in the Operating Agreement. The initial Board of Managers shall consist of two (2) persons. The name and address of the managers serving as the initial authorized member managers (AMBR) until the first annual meeting of members and until their successors are elected and qualify is as follows:

ARTICLE VII--RESTRICTIONS ON MEMBERSHIP
