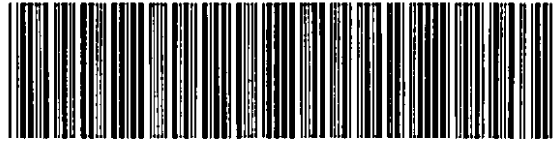

1. Breach of the duty of loyalty to the limited liability company.
2. Acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law.
3. Transactions from which an improper personal benefit is derived, or a wrongful distribution in violation of Florida Statutes.
