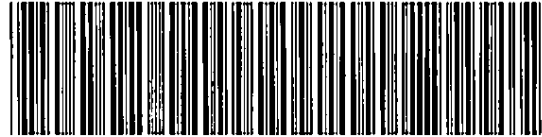

Hi Rebecca,

We are in the process of creating a video featuring our founding story and how the humble beginnings of CEO helped to kickstart the growth and establishment of the entrepreneurial discipline. The video will run for about 4-5 minutes and include Gerry Hills (formerly UIC and Bradley), Michael Hennessy of the Coleman Foundation, John Hughes of the Hughes Foundation, Tony Mendez (formerly with Kauffman Foundation) and likely a brief comment from Giles Hertz, CEO's President to talk about the future of CEO.

I am writing today to see if you might have any contacts at UMKC, Bradley University or TCU. I am hopeful that you might help approach each campus to see if they would be interested in sponsoring the production. The sponsorship would be \$2,000 and will feature their program logo, website and a blurb of support from their choice of university representative. We plan to release this video at our upcoming 2020 Global Conference & Pitch Competition in Chicago as a homecoming tribute to the organization. We will utilize this video in our new chapter establishment materials, in donor conversations and will release it among our network after its debut at the conference. I anticipate that this production will have a lifelong purpose of conveying our origins story for decades to come.

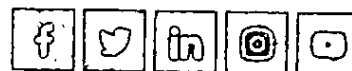
