1. The Articles of Organization of the Company are hereby amended to provide that the following officer has been added to their respective offices:

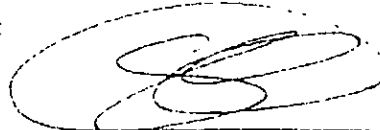
