**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF JP WISEMAN CONSTRUCTION SERVICES LLC**

The Articles of Organization of JP Wiseman Construction Services LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on May 26, 2020, effective as of May 27, 2020, and were assigned Florida document number L20000143217. 
ARTICLE IV - MANAGEMENT
