**ARTICLES OF ORGANIZATION
OF

The undersigned, acting as an authorized representative of a limited liability company to be formed under the Florida Revised Limited Liability Company Act, as amended (the "Act"), hereby forms a Florida limited liability company (this "Company") pursuant to the Act and hereby sets forth the following Articles of Organization (these "Articles"):

ARTICLE I
Name

Duration; Effective Date

The Company shall exist perpetually, effective as of June 2, 2020.




